
- (i) **SRI. S.R. KIRON**, shall be a Trustee for life and shall be the Managing Trustee of the Board of Trustees for life or until he resigns or refuses or is otherwise disable to hold the office of the trustee.
- (ii) **SRI SIDDHARTH K T**, shall be a Trustee for life and shall be the Chairman of the Board of Trustees for life or until he resigns or refuses or is otherwise disable to hold the office of the trustee.
- (iii) **DR. SHWETHA S**, shall be a Trustee for life and shall be the General Secretary of the Board of Trustees for life or until he resigns or refuses or is otherwise disable to hold the office of the trustee.
- (iv) **SRI B.R. KRISHNA MURTHY**, shall be a Trustee for a period of 3 or until he resigns or refuses or is otherwise disable to hold the office of the trustee. He shall have all such powers that are necessary for achieving the objects of the Trust and shall discharge his duties subject to control, supervision and direction of the Board for the time being constituted.



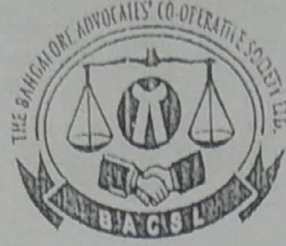

(v) **SRI B K RAMACHANDRA**, shall be a Trustee for a period of 3 or until he resigns or refuses or is otherwise disable to hold the office of the trustee. He shall have all such powers that are necessary for achieving the objects of the Trust and shall discharge his duties subject to control, supervision, and direction of the Board for the time being constituted.

b) **Clause 5(b)** of the original Trust Deed shall be elaborated as follows:

The Board of Trustee shall have the power to co-opt Trustee from time to time subject to maximum of 15 trustees. The office of the Trust can be occupied only on Co-option by the Trustees and not by succession of any of the existing Trustees. In case of demise of any Trustee, the office shall remain vacant until the Board of trustees Co-opt any person in lieu of the demised trustee.

c) **Clause 5(f)** of the original Trust Deed shall be deleted and consequently be replaced with following:

The Board of Trustees shall meet from time to time, as and when necessary for considering the betterment of the Trust and its assets. The quorum for the Board of trustees shall be half [1/2] the number of Trustees. Notice of all meetings of the Board shall be sent to every member of the Board of Trustees either by ordinary post or otherwise. In absence of Sri Siddharth K.T the secretary of the Trust shall be the Chairperson of that specific meeting

Unless otherwise agreed upon, Mr. Siddharth K.T shall chair all meetings of the board of Trustees.
